LEAVING IRAQ: BEGINNING OR END ?

Trouble brews even as US forces celebrate an end to American combat operations in Iraq. The two major factions within Islam, the Sunnis and the Shiites gear up for what will essentially be a civil war. Violence is already spiking in anticipation of the reduced American role. On August 17th a homicide bombing took the lives of 61 Iraqi military recruits.¹ It was just one of several attacks that signal a looming security breakdown in the country. The news barely caused a ripple in America. We've become inured to terror violence that does not hit us directly. Now don't misunderstand. The end of combat does not mean that the US Army is completely gone from Iraq. The fact is that there will still be "advise and assist" brigades as well as Special Forces units – to the tune of nearly 5,000 strong - to assist in anti-terrorism operations.² However the US presence is greatly reduced. Add to that natural Sunni-Shia tension the fact that Iran is Shiite and has been a supporter of the terror militia's of their co-religionists in Iraq. DEBKA, the Israeli political and military news source is taking this very seriously. As they put it, "Iran's followers stand ready to seize Iraq's oil-rich South potentially sparking yet another world conflagration." Iranian Revolutionary Guards units are working with Iraqi elements "to take over the southern oilfields centering on the city of Basra, which account for about 60 percent of the country's oil output." Finally, there is tension between the Kurds of the North and the ethnically Iraqi south.³ Saddam Hussein campaigned against the Kurds, even using chemical weapons against them. And we'll have something to say about the prophetic connection between the Kurds and Babylon (southern Iraq) in just a little bit.

But first let's address a strange little quirk of history. The British writer HG Wells published his book, *The Shape of Things to Come* in 1933. The book is a work of science fiction that purports to reveal the history of the future, all the while promoting a World Government and the elimination of all religion. It's interesting that in that work, Wells predicted that a second world war would break out through a crisis between Germany and Poland over the disputed port of Danzig / Gdansk – in January of 1940. For the record, that war did break out – over that very issue – in September of 1939. Wells – more famous for his authorship of *War of the Worlds* – was a committed New-World-Order-guy. He went on to state that "the plan for the 'Modern World-State' would succeed in its third attempt (Third World War) and would come out of something that would occur in Basra, Iraq."⁴

Interesting as these secularly prophetic musings may be, they are not Scripture. But Scripture does have something to say it seems, about Iraq's future fate. We must begin by realizing that southern Iraq was the seat of the Babylonian Empire. Saddam Hussein even began the rebuilding of the ancient city and sometimes publicly considered himself the new Nebuchadnezzar, the ancient Babylonian Emperor. Babylon, built on the ancient plains of Shinar, was the seat of the religious rebellion against God – [you know, Nimrod, the Tower of Babel and all that...] – and therefore the seat of the Mystery Religions and the mother of the pagan religions and the occult. As such, the Book of Revelation promises that "Mystery Babylon" will indeed be judged during the Tribulation. Scholars are divided as to whether this judgment will fall on a physical Babylon or its spiritual / secular offspring - or both. Revelation 17:5 calls this World System that was born of man's rebellion, "**MYSTERY, BABYLON THE GREAT, THE MOTHER OF HARLOTS AND OF THE ABOMINATIONS OF THE EARTH.**" Revelation 18:2-3 goes on to detail that judgment against what seems both the physical Babylon and that World System that it spawned. "**Babylon the great is fallen, is fallen, and has become a dwelling place of demons, a prison for every foul spirit, and a cage for every unclean and hated bird. For all the nations have drunk of the wine of the wrath of her fornication, the kings of the earth have committed fornication with her, and the merchants of the earth have become rich through the abundance of her luxury.**" But these events are reserved for times yet future – during the time of the Great Tribulation. There are prophecies though that seem to refer to both the very recent past and what may be looming just over the horizon.

“The Prophet Isaiah declared **“The burden against Babylon...A tumultuous noise of the kingdoms of nations gathered together! The LORD of hosts musters The army for battle. They come from a far country, From the end of heaven— The LORD and His weapons of indignation, To destroy the whole land.”** (Isaiah 13:1, 4-5) In both the First and Second Gulf Wars, the US – a nation on the other side of the globe from Iraq, therefore a **“far country”** – led a coalition of **“the kingdoms of nations”**. But surely we didn’t destroy the whole land? Well, not physically...but perhaps. While we don’t have enough space to go into it here – it can be argued that the rampant use of Depleted Uranium munitions by American forces has spread radiation around the entire country – wherever combat has taken place – resulting in sickness and slow death – not only among the Iraqis but also returning US troops.

And then there is the coming fight with the Kurds of the north. The Kurds are the descendents of the Medes, junior partners in the Medo-Persian Empire which conquered Babylon – (but did not destroy it) – back in Daniel’s day. Saddam’s chemical campaigns against them may have resulted in as many as 50,000 civilian deaths. There is no love lost between Iraqis and the Kurds / Medes. They will not be bribed by some ‘neat’ political arrangement. The Bible indicates that these Medes / Kurds will be an instrument of severe judgment against Babylon and what it calls the Chaldeans. **“Behold, I will stir up the Medes against them, Who will not regard silver; And as for gold, they will not delight in it. Also their bows will dash the young men to pieces, And they will have no pity on the fruit of the womb; Their eye will not spare children. And Babylon, the glory of kingdoms, The beauty of the Chaldeans’ pride, Will be as when God overthrew Sodom and Gomorrah. It will never be inhabited, Nor will it be settled from generation to generation”** (Isaiah 13:17-20) Thus this winding down of American involvement may just be opening the door to the next phase Iraqi / Babylonian history...and the fulfillment of God’s prophetic purposes and plans.^{5 6}

ECONOMICS & REVOLUTION – PART XVII

The last time out we drew some of the connections that existed between the PTB through Wall Street with the Communist revolutionaries in Russia. That tie was more than political. It was religious as well. The nature of the current ‘Plan’ is that it envisions a totally centralized and controlled One World Entity. They are seeking; - Political, Economic & Religious unity on a global scale. The Bible tells us that they for a time will succeed in such an arrangement – under the government of the Antichrist. In this installment we’ll continue to focus on the machinations of the PTB as they worked toward building their coming empire.

THE SMELL OF TREASON

“Then they said, "Come, let us build ourselves a city, with a tower that reaches to the heavens, so that we may make a name for ourselves” (Genesis 11:4)

So we’ve observed the involvement between the Rothschild led Central Banks of Europe and American elites such as the Rockefellers, Harrimans, Morgans et al, as well as the aristocracy of the British Empire, led by the likes of Lord Milner of Rhodes Round Table fame and abetted by the newly formed Royal Institute of International Affairs (RIIA), - equivalent of the American Council on Foreign Relations (CFR). The Wall Street elites harnessed the social unrest of the socialist, communist and globalist movements to their own ends. They provided the money for the pre-WWI rise of Germany, as well as its recovery and rearmament after that first war. They also lent their support to the Bolshevik / Communist Revolution in Russia and kept that regime afloat when it seemed doomed to fail. This was an alliance of Anglo-American aristocracy and Jewish banking. These latter seemed to at times be working against the interests of their own people. It was Jewish money that purchased the real estate of Palestine from its willing Arab owners, - but also Jews that financed the rise of the virulently and proudly anti-Semitic Nazis. We pick up the story in the 1930s as the Second World War approaches, tracing the involvement of the highest, often most respected families of the British and American elites, demonstrating some of their collusion with the worst evils of the last century.

Here is the short history of the 1930’s, the decade leading up to WWII. The Western democracies, (Britain & France), tired and morally bankrupt after WWI, - and suffering guilt over the harsh terms imposed on Germany by the Versailles Treaty, - allowed the Germans to get in the game by rearming, marching into the Rhineland –(German territory but demilitarized by the treaty that ended World War I), annexing Austria, then the Sudetenland – (the ethnically German part of Czechoslovakia), and finally the rest of that poor country. The story goes that weak leadership in London and chaotic governmental changes in France enabled the Nazis to come to their position of power, - under the radar, as it were. In the event, it was the voice of Winston Churchill and his small but growing political and media allies, who were the only ones

sounding the alarm of coming war. While true, the fact is that there were forces in very high places that supported the German dictator, not only in the years leading up to the war, - but even during the time it was being fought.

It was during the 1930's that an informal, yet powerful party operated behind the scenes in Britain, to advance Hitler's cause. It was centered around the home of Lord Astor and came to be known after the name of that house as the 'Cliveden Set'. This group of British aristocracy was able to critically influence British foreign policy, preaching appeasement from the time of the Rhineland crisis. Controlling powerful media outlets, - including the London Times, it was able to place articles in influential forums that consistently argued the German cause, systematically ignoring or excusing the excesses of Herr Hitler. This informal group boasted membership of not only the Astors, but Lords Halifax, Lothian and Milner too. These latter members of the Round Table created by Cecil Rhodes in the 1890's, - had the expressed purpose of uniting the world under the auspices of an expanded British Empire. This was the Anglo-American cabal, if you will. Rhode's globalism had come fully to roost in British government policy, even to the point of supporting the German domination of Europe.⁷ That's the route that was taken by Prime Minister Chamberlain when he agreed to the dismemberment of Czechoslovakia. Contrary to its stated intent that it would bring "peace in our time" - that dissection of Czechoslovakia made world war inevitable. It is often forgotten that even President Roosevelt signaled his support of the Munich Conference prior to the event. So it was the internationalist Cliveden Set, - aided by the American ambassador to Britain, Joseph Kennedy, - the father of the future president, - that put together the package of proposals that Chamberlain laid before the feet of Hitler at Munich.⁸ That group was descended from the Rhode's Round Table, (with its Rothschild influence), - fully networked with the RIIA, - and through that to the British Foreign Ministry. Some have gone so far as to charge that it was the intent of some members of this cabal to build up Germany, and to encourage its expansionist tendencies in order to draw it into another war to finally destroy it. Lord Halifax went so far as to admit in March of 1939, that it was policy to "secure...the certainty of a war on two-fronts".⁹

So we saw how the Anglo-American banking establishment was directly connected to the German banks financing of Hitler's 300,000 plus brown shirt army that used violence and intimidation to muscle him into power. Yet the cooperation of both British and American firms continued during the war itself. In February of 1940, even the mainstream LIFE Magazine carried a story and pictures with the caption: "Oil for Germany moves in these tank cars of American Essolube and British Shell". While the British were at war with Germany, and America was decidedly hostile, British and American oil companies were feeding the Nazi war machine. Essolube was part of the Rockefeller empire, - that again was directly connected to the Rothschilds and their confederates. Rockefeller's Standard oil again came to the rescue of the Germans when the Luftwaffe ran short of fuel, arranging transport of oil via Spanish tankers from their refinery on Aruba. As late as 1945, almost one-half of Germany's high-octane fuel needs were produced by IG Farben, which again, was intimately connected with - you guessed it, - Standard Oil.

IG Farben was also responsible for the production of Zykon-B, -the gas that was used in the gas chambers to exterminate the Jewish prisoners.¹⁰ It is interesting to note that it's been reported that the facilities of IG Farben were never bombed by Allied bombers during the war, - and that it was the company's American partners that negotiated that immunity.

There's more. ITT was supplying the Nazi war machine with telephones, radar equipment, air raid warning systems and tens of thousands of artillery fuses; - 50,000 a month in 1944. GM owned Adam Opel and Ford had a wholly owned subsidiary in Cologne that were building German tanks. The Duponts as well as Imperial Chemical of Britain were tied in with IG Farben, and both were indicted for it. And a Philadelphia company controlled by Sweden's SKF was supplying Hitler with ball bearings, shipping them to South America first. Even one member of the American War Production Board was compromised; - his business partner being a close relative of Herman Goering, head of the German Luftwaffe.¹¹

To muddy up the waters even further, let's introduce more information implicating members of additional powerful American families. The National Archives reveal that beginning in October of 1942, - after the US was at war with Germany, - the government seized the Union Banking Corporation under the *Trading With The Enemy Act*. Directors of that firm included Prescott Bush, grandfather of President George W Bush, 'Bunny' Harriman, - from the powerful Democrat affiliated family, - and three Nazi businessmen. Within weeks the assets of three more companies were seized. One US government office announced that these companies had effectively "been operated by the German government" since 1939. There is little dispute that during the run-up to war in the 1930's the American partners were active in these businesses that contributed to the rearming of Germany and the consolidation of Nazi power. Whether this continued after America's entry into the war is a little less clear. The official Bush family position has been that these were mere holding companies for clients. Still there is a direct connection with Fritz Thyssen, & the Consolidated Silesian Steel Company.

Thyssen's German partners did use slave-labor from the concentration camps during the war. Prescott Bush was further implicated by the US government as part of a joint ownership-group in another Nazi firm, the *German Steel Trust*, - through a system of interlocking directorates. That company was responsible for supplying the German war effort with over half of its pig iron, over a third of its explosives and major portions of heavy plate, galvanized sheet, pipes & tubes, wire and other military-industrial needs. One former prosecutor intimately familiar with the situation believes that the American owners knew exactly what they were doing. He makes the case that Prescott Bush, his father-in-law (George Walker), and Harriman should be prosecuted "for giving aid and comfort to the enemy".^{12 13}

Jump forward to the 1970's. We see this elite group at work again, this time in the manipulation of currency values through the availability of oil. It was at that time that the American super-diplomat, Henry Kissinger, who Deanna Spingola describes as "Rockefeller's well-compensated, multi-purpose minion", - arranged the removal of the dollar from the gold standard and the subsequent 400% rise in OPEC oil revenues. Kissinger described the action as "recycling the petrodollar flows". Spingola points out that it was a meeting of the elite of the elite that set the stage for this dramatic action that forever altered the dynamic of the global economy. The meeting was conducted under the auspices of a super-secret group called the Bilderbergers. It included of course Kissinger, and Brzesinski, as well as David Rockefeller himself. Also represented was the CFR, Exxon-Mobil, Atlantic Richfield, British Petroleum and the Warburgs among others. The 1973 Yom Kippur war between the Arabs and Israel played right into the hands of this group. It virtually guaranteed the huge price increase that the Bildebergs were seeking. Whether planned or not, the removal of the dollar from the fixed exchange rate of the gold standard was an unmitigated disaster for America. Inflation, unemployment & interest rates all shot up into double digits. The US moved from being the world's biggest creditor to its' biggest debtor.¹⁴ As for the oil companies and banks and families represented at the Bilderberg confab: Their revenues shot through the roof.

So what's behind all of this? Unbridled corporate greed! Anglo-American foreign policy has become the provenance of the very, very rich, - regardless of political party. In fact, 'Party' seems almost irrelevant to the ultimate goal. As seen in the representation at the Bildeberger meetings, - the multi-national corporations were the money behind the policy. Here's the thread. American and British policy is virtually dictated by the CFR and the RIIA. The CFR is controlled not by diplomats but by the multi-nationals themselves. Here's just a few of the Fortune 500 companies with multiple Council Memberships, Directors or Partners on the CFR: US Steel, Mobil, IBM, Exxon, Chase Manhattan, JP Morgan and Co., Morgan Stanly, Lehman Brothers. And their influence has been increasing exponentially since the end of World War II.

It was through CFR influence, (advanced specifically by a Rockefeller funded study), that the US entered into "full-blown imperialism", during and after the War. One chapter heading was even dubbed, *Shaping a New World Order: The Council's Blueprint for World Hegemony, 1939-1975*. Part of that blueprint included the Marshall Plan that used American dollars to save Western Europe from Communism while feeding those dollars to American companies in the process. It brought us the International Monetary Fund and the World Bank, under the control of British and American interests. It also brought us the UN. The policy that was being pursued through it all was, - 'Unbridled Capitalism'. The Rhodes Round Table plan had been to "gradually absorb the wealth of the world" as the means to establishing the New World Order. The CFR was the means used to fashion the international system that would serve as the tool for accomplishing that.¹⁵ Doubt it? Then here are the words of longtime CFR member, US Rear Admiral Chester Ward, "The main purpose of the Council on Foreign Relations (CFR) is promoting the disarmament of US sovereignty and national independence and submergence into an all-powerful, one world government".¹⁶ Admiral Ward tells us that the objective of the "most powerful clique in these elitist groups" is "a new political order. In my view, the CFR represents a skillful, coordinated effort to seize control and consolidate the four centers of power: political, monetary, intellectual, an ecclesiastical".¹⁷

Ultimately this is all tied back through the Rockefellers, and Morgans and Lehmans - to the Rothschilds and Warburgs and the like that gave them their start and then united with them in common cause. Aware or not, that common cause is nothing less than the fulfillment of the Satanic vision of a world totally controlled; - in the economic, political and religious spheres. They're working for the coming of the Antichrist. In his 1980's book, *The Armageddon Script*, illuminist author Peter Lemesurier brazenly calls him by that very name, - 'Antichrist'. 'The Plan' is in place, - and working very well, thank you! Scripture addresses this very thing in John 5:43. **"I have come in My Father's name, and you do not receive Me; if another comes in his own name, him you will receive."**
