JUST OVER THE ECONOMIC HORIZON

Here's a happy little headline to kick things off. *"This year, US public debt could reach end game."* The article in the Asia News goes on to cite Fed Chair Ben Bernanke's warning to Congress that a Greece-like fiscal crisis looms for the US. Between having to refinance short term debt along with additional deficit spending will mean that the US will need to borrow about \$3.5 trillion this year.¹ Put another way, this year's deficit alone comes out officially at \$1.4 trillion. Yet in reality that number should read more like \$2 trillion. You see, the problem is even worse than what is officially being reported. That difference exists because over the course of years the government has changed the way that it calculates the various numbers used to measure these things...along with so much else. It does not take in, for instance, what are called "unfunded liabilities." Pete Morin, writing in the *American Thinker*, gives us an idea of just how bad a fix we are in. *"Our unfunded liabilities far exceed our assets. Adding up all unfunded liabilities for Social Security, Medicare, Medicaid and Government sponsored pension funds gives us a figure slightly in excess of \$100 TRILLION dollars."* And it's not just the Federal government that is danger of fiscal collapse. The economies of states like California and Michigan are "in far worse shape than Greece's".^{2,3}

Still, despite the looming danger, the government in Washington continues to spend and come up with new programs... [*It's almost like it was planned...to collapse the current world financial system and allow the PTB a chance to build a new one according to their own specifications.*] Even elements in the government – like the Pentagon and Secretary of State Hillary Clinton – a member of the Cabinet – are publicly warning that the skyrocketing debt is a threat to national security. Clinton said, "It undermines our capacity to act in our own interest." The US Military had this take. As deficits continue to rise, the cost of borrowing and servicing that debt will rise – making fewer dollars available for America's defense. That in turn, will of course affect our ability to project power and conduct a successful foreign policy. That means it will become more difficult to protect American interests. Economic historian Niall Ferguson explained this in a Newsweek piece in late 2009. "This is how empires decline. It begins with a debt explosion. It ends with an inexorable reduction in the resources available for the Army, Navy, and Air Force."⁴ Jerome Corsi recently pointed out the historical parallels with the collapsing British Empire of the 20th century. Great Britain faced a similar situation between the First and Second World Wars. Interest comprised 44% of their budget, "inhibiting its ability to rearm against Germany." That hampered the British response to Hitler early on – when he could have been stopped at little cost. The end game there was World War. The US might well be similarly hobbled by its debt.⁵

What we are experiencing now is not just a hiccup in the US economy. Many are calling this the "Great Recession". It is a global event. Matthias Chang says it "is nothing like previous economic downturns", but rather a crisis threatening "the unraveling of the current dollar-denominated fiat money system." In other words, in his view, we are heading toward a new economic world order. [*Now we wouldn't be mentioning him at all if he had not predicted the "Financial Tsunami" that hit beginning in 2007.*] Is this planned? Well it's interesting to note that after holding steady for the lifetime of its existence, the dollar has lost 98% of its value since the Federal Reserve came into existence in 1913. That's when the finances of America were entrusted to the control of the international banking families that operate that private organization. These same groups comprise much of the higher echelons of the Illuminati. And they are trying to assert further control over our currency. The IMF, is gathering support for their proposal that the dollar be replaced by something called "bancors", an idea of that most famous British economist, John Maynard Keynes. That is to someday replace the dollar as a world's global currency. [*From there it would only be a short stretch to imagine that any future global or regional currencies would be electronic in nature....perhaps even activated by an implanted chip. "And he causeth all, both small and great, rich and poor, free and bond, to receive a mark in their right hand, or in their foreheads. And that no man might buy or sell, save he that had the mark, or the name of the beast, or the number of his name."* (Rev 13:16-17) (KJV)] Control of the currency is the key to controlling the population – which in turn is the key to setting up a truly global world government. And with what we are observing we can see it is on the horizon.

But is our economy really in such dire straits? If I'm reading this right, it may very well be. For lots of long and technical reasons a number of experts – like the folks at Matterhorn Asset Management and elsewhere – are seeing trends that will drive the price of gold up into the stratosphere – with “targets” being set at \$6,000 or even \$10,000 an ounce.⁶ That's just about the very definition for hyperinflation – a loss of faith in the currency in favor of real goods. And that's exactly what happened following the end of the First World War in Weimar, Germany - when people had to trade wheel barrels full of marks for a few groceries. Economic collapse there, begat social disintegration. That in turn begat dictatorship – under the Nazis, as people were desperate to find social cohesion and economic security.

We may be closer than we think to the economic chaos that would be the set up for such a scenario. Matthias Chang, with a solid record of predicting economic developments, sees “massive bank runs” hitting in 2011. Chang explains how that would set off a reaction from the Federal Reserve and its sister central banks around the world that would amount to an economic dictatorship as they move to head off disaster. He sees limits on cash withdrawals, restrictions of trade in gold & silver – possibly even confiscations, and capital controls. Chang even envisions governments decreeing that would “compel most daily commercial transactions to be conducted through Debit and / or Credit Cards.” The Daily Bell says that this global unraveling could move us toward a “full-fledged global currency.”^{7 8} He of course is not alone. These predictions are only variations on those of the likes of Gerald Celente – who sees the unraveling occurring progressively through 2012 – as well as our friends at LEAP 20/20. That European think tank sees exploding debt in the US and the West leading to “hidden mass austerity” on the part of governments. That, along with developments in Europe and China, will fuel a giant contraction of the American economy, causing the “acceleration of world geopolitical dislocation.”⁹ While all of this is not written in stone, conditions are ripe for the fruit to fall.

AN OPEN CONSPIRACY

“Why do the nations conspire and the peoples plot in vain? The kings of the earth take their stand and the rulers gather together against the LORD and against his Anointed One.” (Psalm 2:1-2)

“Some of the biggest men in the United States, in the field of commerce and manufacture, are afraid of something. They know that there is a power somewhere...so complete, that they better not speak above their breath when they speak in condemnation of it”. (Woodrow Wilson, The New Freedom, 1913)¹⁰

British socialist and author, HG Wells dubbed it “The Open Conspiracy”. He was referring to the networked inevitability that surrounds and defines power today, in the US, and in Britain, and elsewhere in the West. It is a ‘system’ of interlocked men of influence that is advancing the cause of world socialism, - for their own purposes, - but also because they have been indoctrinated into believing it is the right thing to do. It includes, Democrats and Socialists and Communists and liberal university types, - but also Republicans and bankers and industrialists and entrepreneurs. What began as a conspiratorial plot advanced by the likes of Cecil Rhodes has devolved into a “Network of Power” feeding off of its own twisted ethic. Dr Dennis Cuddy tells us it began as a group of “like-minded globalists ... in key positions in politics, economics, education and journalism”, but it has advanced and taken hold, so this “conspiracy was no longer necessary”. It remains now as an independent “global network of power elite pursuing world government” for its own sake.¹¹ The conspiracy part is no longer necessary. It feeds off of its own misguided, utopian, power-grabbing dreams, packaged and sold to the masses as the only hope for peace...and security.

Rhodes' group came in to formal existence in 1891, as a gathering of the elite of the elite of the British Empire. Founding member William Stead later explained its purposes: A “society copied from the Jesuits” that would end all war, uniting the globe under a universal language by “gradually absorbing the wealth of the world” in pursuit of a “government of the whole world”.¹² To that end the prestigious Rhodes Scholarships were established, to train a class of ‘world servants’ to carry the torch of this globalist vision into the future. The most famous of the recent class of Rhodes Scholars is of course former President Bill Clinton, - but many dozens have occupied positions of extreme influence. Now the plan they hatched was not unique. It became the dream of many, operating from several centers of power. It was but the marriage of socialism and capitalism; - what has become known in modern parlance as the Third Way; - with such modern proponents as Britain's former Prime Minister Tony Blair and President Clinton. In fact it was actually tried before in the Germany of the 1930's & 40's, where Hitler oversaw a brand of socialism organized on a national basis;- and established to advance nationalist ends. [It's rather remarkable that the Nazi experiment was viewed at first by many occult and illuminati types as possibly the onset of the New Age. It was only later that they deemed Hitler to be of the school of ‘black witchcraft’ as opposed to the ‘white witchcraft’ favored by the likes of Alice

Bailey and the Theosophists. Still, Bailey considered Hitler part of the “Shamballa Force”. Other New Agers signaled their approval too, with Savitri Devi Mukherjee, a French convert to Hinduism, calling the brutal Nazi dictator “the greatest European of all times” and founding a movement that survives in India to this day.^{13]}

HG Wells explained the ‘plot’ as the synthesis of the two systems. Governments would rise and fall but the bureaucracies would remain in place to steer the course, making the political figureheads somewhat, - and increasingly irrelevant.¹⁴ The ethic of the One World and progressive globalization has become the underlying ethic of the ruling class. The idea of a New World Order has become a natural ‘way of thought’. Just look at any of the serious candidates that have sought the nomination of Democrats or Republicans in the last several elections. Almost all are members of, or have sought the approval of something called the Council on Foreign Relations. The CFR is the Establishment arm that informs and indoctrinates the movers and shakers of America. It is the driving philosophical force behind the State Department’s career diplomats. Even would-be conservative politicians have looked for its nod of approval and respectability by publishing their policy articles in the pages of its periodicals. (In the 2008 Republican Presidential Primary we witnessed a seemingly major incongruity in Baptist Minister / Politician / Governor of Arkansas and candidate Mike Huckabee. His words too, graced the pages of the CFR’s periodical *Foreign Affairs*. That magazine is the common currency of the American presidential candidate.)

The CFR is the American counterpart of the London based Royal Institute of International Affairs, (RIIA), which was formed after the First World War. But representatives of American economic power were present even from the beginning. Professor Carroll Quigley, was the only man to be given access and support by the Illuminati elite to write their history. He characterized the CFR as strictly a front for the JP Morgan business interests. Ted Flynn called them a “Who’s Who of the power elite...cosmopolitan, Anglophile, internationalist, Ivy League, Eastern seaboard, high Episcopalian, and European in outlook”. From its inception they had their hands all over the American intelligence community through the manning of key positions in the CIA.¹⁵ The British group, guided by Lord Milner, was in close relationship with both Morgan and Carnegie interests. By 1921, political string-puller and Wall Street lawyer, Elihu Root managed the merger of the RIIA with the American CFR. It soon emerged as the guiding voice behind Anglo-American policy.¹⁶ Even CFR member, award winning historian Arthur Schlesinger, as well as CFR researcher Professor Carroll Quigley have referred to the organization as but a “front” for the powers-that-be. [It is for instance, the Council that provides the intellectual justification behind the move toward a North American Union.] Now, it is this Professor Quigley that has led the drive to reveal the depths of this ‘Open Conspiracy’. A 1975 article about him in the Washington Post was entitled “The Professor Who Knew Too Much”. It was Quigley who first exposed the depth and interlocking nature of the relationships between economic and political sources of power. It was the industrialists and the banking elites, beginning in the 19th century that formed and still drives this power base.

Now the CFR has multiplied its influence by providing dozens of key members for the presidential administrations since its founding in 1921. By the year 2000 it had furnished 14 Secretary’s of State, 14 Secretary’s of the Treasury, and 11 Secretary’s of Defense. This was not just a gentleman’s club but was an entity dedicated to a purpose and a cause; and that cause was not the furtherance of the national interests of the United States of America. CFR member Admiral Chester Ward was quoted by Harper’s Magazine in 1954 saying, that the Council on Foreign Relations was founded for “the purpose of promoting disarmament and submergence of U.S. sovereignty and national independence into an all-powerful one-world government”.¹⁷

It was in the fading years of the 19th century, that a plan was hatched under the auspices of William C Whitney, to take control of both major political parties using financial contributions and control the Presidency. According to the Professor, the plan was in effect about 16 years, and after that the candidates of both parties were “moved...toward the political center”. Besides relieving the nation of dealing with that messy democratic-republic-thing, the other service that Whitney provided his country was to elevate the influence of Yale University’s Skull & Bones Society.¹⁸ Its members, - along with the Rhodes Scholars began to show up in every important position of power in the nation, - again promoting the agenda of the elite. Of course, both Presidents Bush were members of that secret society along with scores of the nation’s elites. Some other family names that you may recognize include Bundy, Adams, Taft, Pillsbury (of flour fame) and Weyerhaeuser. Just for the record, Skull and Bones is not even an ‘American’ secret society. Also known as the “Brotherhood of Death” it had its origins in a German organization that was outlawed there in 1832. Historian Anthony Sutton calls it “a clear and obvious threat to constitutional freedom in the United States”, with an influence that is even greater than the Masons.¹⁹

This contrived system ended up putting in power the major cultural change agents of the last century: Author HG Wells, economist John Maynard Keynes and the Father of Modern Education John Dewey among them. Take education for instance. Through the influence of Dewey and the denizens of the NEA, the purpose of education, - at the macro-level, - became not the education of children, - but the transformation of the culture. Charlotte Iserbyt, a former member of the Reagan era Department of Education uncovered the plan that has changed American education beginning with Dewey’s influence in the early part of the 20th century. Earlier, we documented how the educational elite, - (firmly committed to New Age / One World values), - put a

new system in place that employed a “psychology based curriculum” to transform the beliefs and values of the dominant culture. One high National Education Association (NEA) official admitted as far back as 1947 in the NEA Journal that the new purpose of education was to lay the “foundations for wider loyalties...which will result ultimately in the creation of a world citizenship and world government”. A 1990 report was one of many that reaffirmed the goal; - to ‘establish the one world agenda with the United Nations as its center’.²⁰

If we want to see where this is going we need only look at the words of the Peacemaker’s Planetary Anthem, - sung to the tune of the Star Spangled Banner, - at an elementary school assembly in Sunnyvale, California.

“Oh Say can you see by the one light in all

A New Age to embrace at the call of the nations”

It goes on ad nauseum promoting a collective consciousness and general one-worldism. Christian researcher and author Berit Kjos tells us of one *Rescue Mission Planet Earth*, that uses teachers to turn students anger against their parents and elders to motivate (in Kjos’ words) “political action on behalf of the United Nations and planet Earth”.²¹ Al Gore goes even farther, shaking off the country’s Christian roots in advocating a “panreligious perspective” in the effort to revolutionize the “relationship” between we evil humans and our Earth Mother.²²

Even a casual reading of the literature of ‘Big Education’ reveals more of their agenda. One report talks about addressing “root causes” of the world’s problems. The “root causes” referred to would be any traditional values or beliefs that might question or threaten the globalist agenda. A UNESCO paper declares “Tolerance involves the rejection of dogmatism and absolutism”. So God & societal morality, and even absolute Truth is taken out of the schools. There can be none of that in this emerging brave new world. There is even a United Nations plan for mental health that will get everybody thinking on the right track; - and one to prepare “human resources” for a “global workforce”.²³ It is all operating rather openly for anyone who cares to see.

So we can see the pattern here too. Education, like economics and currencies and even national borders are to increasingly become subject to supra-national control: Thus the EU, and the coming North American Union, and the Amero and UNESCO and the United Nations mental health plan, and gun control and international control of the seas and the environment. It is a plan for international fascism. In light of all we have seen during the course of this series we must conclude that the Obama administration and its allies are in the process of advancing that very goal. Let’s review again some what’s been ‘accomplished’ since Inauguration Day, January 20, 2009. Washington has established the principle that It alone is in charge. Chrysler and GM were effectively taken over. Control over the banks and financial industry was established. Then there was Health Care. Despite the President’s promises to the contrary, it has resulted in the public funding of abortions and promises increased government intrusion into our personal lives. We’ve lost control of our borders and the Feds refuse to effectively enforce immigration laws already on the books. And the administration has created a deficit four-times larger than the previous record deficit and asks for a climate bill that would – in the President’s word – make our electric bills “skyrocket”. At the same time, ‘Big Brotherism’ is exploding. There are initiatives in place to collect everyone’s medical records in a data base, - and discussions suggesting that the FTC and the FCC should “impose taxes on selected media” and subsidize the favored liberal media in the name of balance. That would include the internet. That is the softer and official face of an animosity to any kind of alternative media on the part of the White House, expressed as it was, by the constant attacks against FOX News in an attempt to neutralize and marginalize the most conservative of the major news outlets. I do not claim that Obama is a dictator. But government control of the news media is – in the words of Jan Markell, but “the antics of any totalitarian dictatorship be they in a sophisticated nation or a banana republic.” All this should come as no surprise. After all, candidate Obama promised to “transform America”, and he is in the process of doing just that.^{24 25 26 27}

Thus the fight may seem often stacked against us. Still we are required to fight for the right, and commanded to “**put on the whole armour of God...and having done all, to stand**”. (Ephesians 6:13) (KJV) This will not be an easy struggle. We know that we face a determined enemy that is committed to creating a global government. We face a time of increasing chaos in its birthing. One of their chief spokesman, HG Wells, predicted the chaos that would visit the coming end of the nation state. He wrote, “countless people...will hate the new world order...and will die protesting against it”. Scripture tells us that these promoters of this New World Order & Global Government will for a time succeed. However the Bible also tells us that in the end, our God will triumph. This is but a vain rebellion against The Most High God. “**He who sits in the heavens shall laugh; The Lord shall hold them in derision.**” The Father declared: “**I have set My King on My holy hill of Zion**”.
